Lynne Hyde raised concerns about the McCarthy & Stone proposal to build a retirement living development featuring around 50 one- and two-bedroom apartments at Parley Cross.	Lynne Hyde	Sept 24	PPG members have raised concerns about how the development of the area will impact healthcare provision by the Barcellos Family Practice. The retirement development is in addition to the building of up to an additional 386 homes at Kingsmere Park. Given that the whole development falls within BFP's catchment area, and the Glenmoor Road site is the nearest GP surgery, it is possible that anyone relocating to the area may approach Barcellos to register. The PPG wants to formally write to local councillors to express concerns about how the resulting increased demand from new Kingsmere Park residents will impact the provision of healthcare for existing patients. They are seeking input from the Practice for their letter.
