1. Welcome and Introductions

Roger started the meeting with a suggestion that when emailing the group, we use the 'BCC' box so that everyone's email addresses remain hidden and are protected from any potential scams.

2. Approval of the Minutes of the meeting held on 17 September 2025.

3. Update/Discussion on current Action Plan.

Julie gave some updates on Community SWITCH-'Since the last PPG meeting SWITCH has had 614 visitors and 2,472 views. We regularly list about 100 events for the current through next month and periodically promote awareness of the Events page. Latest resources added include:

- OCD UK advice information and support for those affected by obsessive compulsive disorder
- Waythrough addiction recovery support
- HOPe New Forest befriending and practical support for older people
- Age UK BPED range of support services for older people
- Relationships Wessex counselling support for individuals, couples, families
- AbilityNet resources and at home IT support to older people and those with disabilities

There are now 100 resources listed on the programme with more than 20 further organisations currently being reviewed.

There is a Community Event on 1st November in Verwood that Community SWITCH will be represented at. Kate is organising a Community Connections event for 14th January at The Centre, Barns Road, Ferndown – the event will follow a similar format to the Verwood Tackling Loneliness event.'

Kate provided an update on the chatty benches which were discussed in the last meeting- the funding has almost been confirmed now by Ferndown Rotary Club. The first bench will be placed in West Moors and there will be a QR code on the benches which will take you to the Community SWITCH website.

Julie has created a leaflet which explains the roles and responsibilities of various healthcare professionals in the Practice and PCN.

From this, Sophie will look at the 'clinic and services' section on the Practice website, and the PPG are encouraged to look too.

Susan and Janet have kindly offered to keep an eye out on the PPG noticeboards at both practice sites- thank you both!
